

# BUILDING PERMITS – DO I NEED ONE?

The answer is most probably **YES**. Below is a list of common building works and whether they are subject to a **Building Permit**. The Building Act and the Building Regulations state that building work must not be commenced prior to the issue of a building permit. The Act prescribes heavy penalties for any work done without a permit.

Common Types of Building Work	Building Permit Required
<b>Additions</b>	
Additions to a home or any other building	Yes
<b>Alterations</b>	
Structural alterations to a home or any other building	Yes
Removal or alteration of a load bearing part of a building	Yes
<b>Carports/Garages/Sheds</b>	
Freestanding, floor area not exceeding 10m <sup>2</sup> , no more than 3m high, not constructed of masonry and located no further forward on the allotment than the associated building	No
Attached to another building	Yes
Setback less than the associated building	Yes
<b>Demolition/Removal</b>	
Demolition or removal of part or all of a building	Yes
<b>Fences</b>	
Construction of a side or rear boundary fence less than 2m high	No
Construction of a brick front fence more than 1.2m high	Yes
Construction of a timber front fence less than 1.5m high	No
Construction of a side/rear boundary fence more than 2m high	Yes
Construction of a fence that is more than 1m high, within 9m of the point of intersection of street alignment	Yes
Construction of chain wire tennis court fence	No
<b>Reblocking</b>	
Reblocking or restumping of an existing building	Yes
<b>Verandahs</b>	
Construction of a verandah (roofed) attached to any building	Yes
<b>Wood Heaters</b>	
Installation of solid fuel heating appliance	No

Common Types of Building Work	Building Permit Required
<b>Pergolas</b>	
Construction of a pergola (unroofed) associated with a house, not exceeding 20m <sup>2</sup> in area, not more than 3m high and located no further forward on the allotment than the dwelling	No
Construction of a pergola (unroofed) associated with any other building	Yes
<b>Retaining Walls</b>	
Constructed on or near site boundary (any height) in order to maintain the stability of the adjoining property	Yes
Construction of a retaining wall 1m or more in height	Yes
<b>Roofing</b>	
Replacing of corrugated iron roofing with concrete or terracotta roofing tiles	Yes
Replacement of corrugated iron roofing with 'Colourbond' or other pre-finished sheeting	No
<b>Swimming Pools/Spas</b>	
Construction of an swimming pool/spa greater than 300mm in depth	Yes
<b>Windows</b>	
Replacement of windows with similar type windows, where no structural alterations are required	No
Installation of 'bay' or 'corner' type windows where structural alterations are required	Yes
<b>Decks</b>	
Construction of a deck	Yes
<b>Water Tanks</b>	
A tank on the ground and not within 500mm of the side or rear boundary (overflow connected to storm water system)	No
